- 3. I have been advised by ABA, and have had the opportunity to seek legal counsel with respect to the legal effect of this document.
- 4. I KNOWINGLY AND FREELY ASSUME ALL RISKS REFERRED TO ABOVE, BOTH KNOWN AND UNKNOWN, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES (AS DEFINED BELOW) OR OTHERS, AND ASSUME FULL RESPONSIBILITY FOR RISKS ARISING FROM MY PARTICIPATION IN THE TOURNAMENT(S:)
- 5. I willingly agree to comply with the terms and conditions for participation. If, however, I observe any unusual significant hazard(s) in my presence or during participation, I will remove myself from participation and bring such to the attention of the nearest official immediately.
